The Early Intensive Developmental and Behavioral Intervention (EIDBI) benefit is a Minnesota Health Care Program designed to provide comprehensive support for individuals under the age of 21 diagnosed with autism spectrum disorder (ASD) or related conditions. This benefit is available to those enrolled in Medical Assistance (MA), MinnesotaCare, Minnesota Tax Equity and Fiscal Responsibility Act (TEFRA), or other qualifying health care programs. The primary goal of the EIDBI program is to deliver medically necessary, early, and intensive interventions that address the unique

After-School Groups and Summer Skills Groups

Empowering Kids offers essential after-school and summer programming for individuals with autism, ADHD, and other related social challenges. Participants, ranging from ages 10 to 19, come together to learn, grow, and connect in a supportive environment.

During the past year:

-After-School Groups welcomed 12 participants, each attending for two hours weekly.

-Summer Social Groups served 18 participants, with sessions running four hours each week.

Occupational Therapy

Empowering Kids provides individualized Occupational Therapy (OT) services that support children and young adults with autism, ADHD, sensory processing differences, and other developmental needs. Through one-on-one sessions, participants work with a licensed occupational therapist on:

-Fine and gross motor skills - improving strength, coordination, and dexterity for everyday tasks.
